

FACTS**WHAT DOES LOUVIERS FEDERAL CREDIT UNION (LFCU) DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and account transactions
- Payment history and credit history

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons LFCU chooses to share; and whether you can limit this sharing.

Reasons we can share your personal information	Does LFCU share?	Can you limit this sharing?
For our everyday business purposes — such as to process your transactions, maintain your account(s), respond to court orders and legal investigations, or report to credit bureaus	YES	NO
For our marketing purposes — to offer our products and services to you	YES	YES
For joint marketing with other financial companies	NO	We don't share
For our affiliates' everyday business purposes — information about your transactions and experiences	NO	We don't share
For our affiliates' everyday business purposes — information about your creditworthiness	NO	We don't share
For our affiliates to market to you	NO	We don't share
For our nonaffiliates to market to you	YES	YES

What we do

How does LFCU protect my personal information?

To protect your personal financial information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does LFCU collect my personal information?

We collect your personal information, for example, when you

- open accounts or deposit or withdraw money
- get a loan or give us additional account information
- use your credit or debit card

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes — information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- LFCU has no affiliated companies.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- We share information with our check printers, data processors, government agencies, and consumer reporting agencies.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- We share information with our insurance company (CUNA Mutual Group), our credit and debit card processors (VISA and VANTIV), Liberty Mutual Auto and Property/Casualty Insurance and Nationwide Auto Insurance.
